- Authorship will be determined by the primary investigators for this project request, in alignment with these rules
- Co-authorship will only be warranted for collaborators who meet the ICMJE recommendations for authorship (http://www.icmje.org/recommendations/browse/roles-and-responsibilities/defining-the-role-of-authors-and-contributors.html)
- The MaGIC Co-Chairs and Cooperative Group Chairs are not automatically co-authors, they will be co-authors only if they have been actively and intellectually involved in the project.
- To support the training goals of MaGIC, (full) professors are asked to consider co-senior authorship or not being senior author.
